

ONT x LAFC FAN GIVEAWAY OFFICIAL RULES

1. GENERAL AND ELIGIBILITY: No purchase necessary. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. The ONT x LAFC Fan Giveaway (the "Sweepstakes") begins April 17, 2025 at 12:01 a.m. Pacific time and ends on November 30, 2025 at 11:59 p.m. Pacific time ("Entry Period"). Void where prohibited or restricted by law. The Giveaway is sponsored by the Ontario International Airport ("ONT") Authority ("Sponsor"). The Sweepstakes is open to legal residents who live in California within Los Angeles County, San Bernardino County, Riverside County, Orange County and San Diego County (the "Territory") who are at least 18 years old at the time of entry. Employees, officers, owners, and directors (including immediate family members such as spouse, parent, child and sibling and their respective spouses, regardless of where they reside, and members of the same household, whether or not related) of the Sponsor, Los Angeles Football Club ("Club"), Major League Soccer, L.L.C. ("MLS") Soccer United Marketing, LLC ("SUM"), Pro Soccer Development, LP ("MLSNP"), and Player Development, LLC ("PDEV" and together with Club, MLS, SUM, and MLSNP, collectively, the "MLS Entities") and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, agents, and their printers and advertising and promotional agencies are not eligible to participate or win a prize. The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations. Void outside Territory and where prohibited or restricted by law, rule or regulation.

Transportation to/from stadium is not included and is the sole responsibility of each Winner. Each Winner is fully responsible for any and all applicable federal, state and local taxes (including income and withholding taxes). applicable stadium regulations in connection with the Prize. Sponsor and the applicable MLS Entities reserve the right to remove or deny entry to Winner and/or his/her guest(s) who engage(s) in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at any game, event or exhibition. Released Parties (as defined below) will not be responsible for weather, Acts of God, acts of terrorism, civil disturbances, work stoppage or any other event that may cause the cancellation or postponement of any MLS game, event or exhibition.

 - **1. Online Method:** During the Entry Period, go to Ontario International Airport terminals and scan the QR code on ONT x LAFC branded signage. Click on the banners, buttons and/or links to access the online entry form for the Sweepstakes and register by filling out the required fields on the Sweepstakes entry page, which will include:
 - First name and last name
 - Email
 - Instagram Account (if applicable)
 - Departure Terminal (if applicable)
 - Airline flown (if applicable)
 - Whether entrant is flying to an LAFC away match
 - If so, what city the match is in
 - Favorite thing about ONT

By submitting your completed online entry form and all other requested information as directed, you will receive one (1) entry in the Sweepstakes. Entrants must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete entries are void.



Online entrants to the Sweepstakes will be given the option to receive marketing emails from Ontario International Airport; however, eligibility to participate in the Sweepstakes is not dependent upon entrant's consent to receive such emails and consenting to do so will not increase your chances of winning.

2. Alternative Form of Entry: During the Entry Period, you may enter the Sweepstakes by hand-printing your complete name, street address, city, state and zip code, day and evening telephone number (including area code), date of birth and email address on a 3"x5" postcard and mailing it in an envelope with proper postage affixed to: ONT x LAFC Fan Giveaway Sweepstakes, Attention Marketing, 1923 E Avion St, Ontario, CA 91761. Mail-in entries must be received by Sponsor by November 25, 2025 to be eligible for the final drawing. Mail-in entries become the property of the Sponsor and will not be returned.

4. HOW TO WIN: The potential winner(s) of the Sweepstakes (each a "Winner" and collectively, the "Winners") will be selected by random drawing on the first day of each month during the contest period from among all eligible entries received by the Sponsor. The decisions of Sponsor are final and binding on all matters relating to this Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Entry Period. If an entrant doesn't win one month, the entry will stay in the drawing pool for the remainder of the contest period.

Each Winner will be announced on Instagram and notified by email by the Sponsor. In the event that any Winner does not respond to any such notification within one (1) week of the date of issuance, a disqualification will result, the Prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate Winner may be chosen from among all remaining eligible entries. Each Winner may be required to submit identification to Sponsor and will be required to execute, have notarized and return an Affidavit of Eligibility and Release of Liability and, unless prohibited by law, Release of Publicity, within five (5) days of date of issuance.
